

School Merger Study Approved

TARBORO — Edgecombe County Commissioners have approved the formation of a committee to collect facts and figures on the school merger

issue. Commissioner John Williams said he thought the formation of such a committee would be "just spinning wheels," but commissioner J. Vines Cobb suggested the formation because.

Cobb said the committee would not be a "decision-making committee," but one that will gather information that will be helpful in an overall solution to the merger controversy.
The committee, when formed, will have 11 members, consisting of county manager Ellis Williford, board chairman Tom Bardin, Edgecombe County School superintendent Phillip Beaman, Rocky Mount City School superintendent Phillip Beaman, Rocky Mount City School superintendent Max Abbott City School superintendent Max Abbott and two members from each system's school board. Action to form the committee came

Action to form the committee came late in the day, but the issue was brought up first thing at the beginning of the meeting by Tarboro Town Councilman Steve Hoard.

Hoard asked the board of commissioners to consider doing a factiniding study. Hoard said the issue of merger is "paramount"in Rocky Mount and that the leadership in Rocky Mount and Nash County is working diligently for a solution. Hoard said he did not want Edgecombe County jet behind.

Hoard said there have been many studies in the past and many efforts, but the results do not show that the groups have been working together to solve the problems.
Hoard said he did not want Nash County and Rocky Mount to be getting information about merger when "Edgecombe County isn't getting the same."

Hoard said the economic growth of Rocky Mount is "dependent" on the economic growth of Tarboro and the Rocky Mount side of Edgecombe

County. Hoard said it comes down to deciding what is best for the children and the area and having "the guts to do what is best."

"Somebody has got to change the direction of g. ..."h in Edgecombe County." said Hoard, who added that someone is "already doing it in Nash."
Hoard said the leadership in Rocky

Hoard said the leadership in Rocky Mount, which is moving to get the merger controversy settled, "is a different breed of people. I know most of them." Hoard encouraged the commissioners to take their own initiative in merger leadership. He said Nash County is going to do "what is best for Nash County people."

If the merger situation is solved, Hoard said, it will be "the greatest economic stimulation that Edgecombe County can get." If it is not solved, he said, it will be taken "through the courts."

The Edgecombe Board of Commissioners has opened itself to any suggestions and proposals on the merger situation, except for the proposal that "Rocky Mount City School Administrative unit be divided along the Nash-Edgecombe County line and the resulting portions be merged into the county in which each is geographically located." They have opposed this proposal, which has been referred to as county-line merger. The Edgecombe Board of Com-

Edgecombe County commissioners have urged all parties "to cooperate in conscientious efforts to find a better solution to the probleme" confections.

County commissioners met with members from the Rocky Mount City, Tarboro City and Edgecombe County school boards on March 14. Although no action was taken at the meeting, Cobb said he has had several com-ments from members about the good of the meeting.
